## GALE RECEIVES SCOTTISH LAND FUND AWARD

We are absolutely thrilled to share some fantastic news. GALE, has secured a grant offer from the Scottish Land Fund for use towards the purchase of The Shieling. The award is divided into two parts: one part is a contribution towards the acquisition costs of The Shieling and the other is to cover some initial staffing costs associated with the project.

GALE Managing Director, Janet Miles, said "We are thrilled to receive this grant offer, as it symbolises an exciting milestone in a very challenging journey. The outpouring of support from numerous local individuals and partner organisations has been overwhelming. ### Community Land and Asset Ownership

Community land and asset ownership is a relatively new concept in Scotland, but it has already started to bring about significant benefits for local communities. The idea is simple: instead of private individuals or companies owning land and assets, communities take ownership of them and manage them for the benefit of everyone who lives there.

We are already doing this in The GALE Centre which has been in community ownership since it was built in 2012. Like many community owned assets The GALE Centre helps to anchor wealth in our community, creating jobs and economic opportunities as well as meeting social and wellbeing needs. Our neighbour, Gairloch Heritage Museum, is also community owned and so GALE's ownership of the Shieling would close the gap along this roadside strip and create a corridor of community owned buildings/assets. The success of this corridor is itself evidence that community ownership can drive sustained and successful regeneration

### **GALE Shortlisted in SURF Awards**

GALE is pleased to announce that we have been shortlisted for the prestigious SURF Award national awards scheme, which showcases success in responding to regeneration challenges in communities across Scotland. GALE is one on three finalists in the Community Led Regeneration category.

### **SURF Awards**

SURF is a regeneration forum with over 300 cross-sector member organisations across Scotland. Since 1998, the SURF Awards have identified successful regeneration projects of all sizes from across Scotland. This year's shortlisted projects feature major place-making investments, employability initiatives, and activities delivered by community groups and arts organisations in both urban and rural contexts, from Dumfries and Galloway to Unst in Shetland.

The 2023 SURF Awards are delivered by SURF in partnership with the Scottish Government, with additional support from Architecture & Design Scotland, Creative Scotland, Highlands and Islands Enterprise, Institute of Employability Professionals, Scotland's Towns Partnership and Scottish Procurement Alliance.

2023 marks the 25th Anniversary year of the SURF Awards process. SURF's Emma Scott said: "SURF were delighted to mark the 25th Anniversary year with a record number of applications, showcasing the remarkable efforts of communities and organisations throughout Scotland to improve lives and outcomes for both people and place. The volunteer judging panel have had the unenviable task of narrowing those excellent applications down to a shortlist of 15. We look forward to celebrating with all 15 projects at the Awards Presentation Dinner in December, and thank all of the applicants who took the time to share their work, and story, with us."

### The Shortlist

Having assessed applications from Shetland to the Dumfries and Galloway, across five categories, SURF's independent panel of 15 judges, drawn from national bodies and community groups, have agreed upon 15 shortlisted projects for 2023.



# **Membership Adopts New Articles of Association**

At the Extraordinary General Meeting of GALE members, held on 14th September, our members overwhelmingly voted to adopt new Articles of Association. (Just 3% of members voted against the resolution.)

The GALE Board called an EGM to which all members were invited to attend. The purpose of the meeting was to consider a Special Resolution to adopt a new set of Articles of Association. GALE is a democratic, community owned company. Therefore its Individual and Corporate Members have a right and responsibility to vote on matters such as the consideration of a Special Resolution.

The Board encouraged its members to exercise this right and responsibility by attending the meeting or appointing a proxy to attend in their name. We are delighted that so many of our membership exercised their rights and participated in the democratic process.

### Why the Changes Were Proposed?

Our articles must fit within boundaries set by legislation. GALE like any incorporated organisation needs to update its articles from time to time due to legislation changes and new laws coming into place. As GALE is a democratic, community owned company our Individual and Corporate Members have a right (and responsibility) to vote on changes to our articles.

There are two key pieces of legislation that GALE's Articles must comply with, the 2006 Companies Act and the Community Empowerment (Scotland) Act 2015. The latter has opened new opportunities for community owned companies like GALE in terms of land and property ownership for local people. The GALE Board has spent the last two years reviewing the company's articles of association with guidance from our solicitor who is a specialist in community trust law.

GALE members were consulted on proposed new Articles at our AGM last December and while largely in favour of them some points needed some reworking, mainly around GALE's Area of Benefit, the retention of Corporate membership and the lower age limit for members.

### Conclusion

This is a significant step forward for our organisation having articles which fit with current legislation. It opens up greater opportunities for our community in terms of inclusion and democracy as well as increased potential for community ownership of land and property.
